"PLAYERS STANDING FOR STATE SELECTION" – Junior State Champs 2019

This form is for 12's, 14's, and 16's & Under Girls & 16 & Under Mixed players wishing to nominate for State Selection. It will be the responsibility of each Team Manager to have players sign this form

ALONG WITH THE INFORMATION SHEET which is to be submitted to the Tournament Director along with the PLAYERS SIGNATURE on the Team Sheet & Parent indemnity form at the Managers Meeting.

The Australian Junior Nationals in 2019 will be held Action Indoor Sports Toowoomba. Queensland from Sat 30th Nov – 7th Dec 2019. The QLD touring party will assemble on Friday the 29th November at a location set by INFQ to then travel to the accommodation in Toowoomba – Players will be returned to pick up area on Sun 8th Dec.

TERMS & CONDITIONS:

- Must have completed the below information in full and the Players Information Sheet (page2) 1.
- 2. Please note: All players who state their eligibility for a state team, who are subsequently selected for the State Team and then withdraw from the team are subject to penalties as applied by the INFQ Management Committee. These penalties will be dealt with on a case-by-case scenario but will range from loss of deposit to total suspension from any INFQ event for twelve (12) months
- You will be required to present at the announcement of the state teams, if named in state team you will receive a 3. brochure along with the training schedule, and all paperwork which you will need to bring to induction day - filled in and ready to hand in - YOU MUST ALSO bring ID to induction
- Induction Day Monday 7th October Public Holiday BRISBANE WEST INDOOR SPORTS CENTRE 4.
 - You will be required to attend the induction day on Monday 7th October to try on the samples of uniforms (a) and hand back all in the required forms - this day is compulsory for all persons touring.
 - (b) 10.00am for all PLAYERS, COACHES, MANAGERS, UMPIRES AND SPORTS TRAINERS
 - (c) **12.00 noon** ½ hour break
 - (d) 12.30pm 2.30pm 1st State Training session for all teams
- Requirements of being selected: 5.
 - (a) You will be required to attend ALL Sunday training sessions as set down by INFQ. If for some unforeseeable circumstances you are unable to attend, notification must be made with your Manager prior to that training session.
 - (b) If three or more training sessions are missed, you will be asked to show good reason as to why you should not be removed from the team and face further action from the Management Committee (as above)
 - You will be required to make a \$300 deposit (\$100 non-refundable) into the INFQ bank account by COB (c) TUESDAY 8th OCTOBER 2019. Failure to do so could mean the immediate removal from said state team. (d) All payments must be finalised by Tuesday 19th November 2019 – as per below - no exceptions.
 - Costs for the tour will be Approx.: *** \$1350 per player This includes accommodation, ground transport, petrol, sports trainers, team entry fees, umpire levies, tournament package, presentation dinner & insurance etc.
 - This does not include uniforms or day to day expenses re food on tour or food for training
